5. 1. 3. The trustees may invest trust fund in fixed deposits with nationalized banks Government Securities or any other investments as per the income Tax act 1961.
4. The Trustees may convert, call in sell or otherwise dispose any of the properties or investments comprises n the trust property and reinvest or change the nature of any other investment contained there in.
5. The Trustees shall have power to borrow for the purpose of the Trust wherever they think if necessary on the security of the trust property.

### POWER AND DUTIES OF THE MANAGEMENT TRUSTEES

1. The Chairman or the secretary shall ordinary call for a meeting of the trustees not later than every month for the purpose of transacting business.
2. The Chairman in his discretion calls a special meeting for disposal of urgent matters.
3. Not less than seven days notice previous to the date of ordinary meeting shall be given to trustees and in case of adjourned meetings or special meeting three days previous notices shall be given.
4. If any urgent matter may be decided before the date of an ordinary meeting then the matter may be decided by circulating among the trustees but shall be ratified by the trustees at the next meeting.
5. The Chairman shall preside at all meetings of the trustees. In his absent at any meeting the trustees who may be present at the meeting shall elect a president for the meeting. In case of difference of opinion or if the trustees shall be equally divide in opinion or if the trustees shall be decided according to the casting vote of the president.
6. The managing trustees shall regularly maintain proper books of accounts, proceedings of the meetings, to and from registers, correspondence, receipts and vouchers for payments etc., the accounts shall be audited by a professional and well qualified auditor once in year.
7. The president shall have power to grant leave of absence up to six months to any of the trustees who have unable to attend the meeting due to illness or foreign trips or for satisfactory reasons.

### GENERAL

- All the trustees shall perform their duties in the best interest of the trust and put in their sincere efforts to obtain trustful results in attaining the objects
- The trustees shall manage and administer the trust property with at most case and caution so that the said properties as proceeds there of are applied predominantly for the purpose of the trust.
- The trustees at all times be bund by the provisions of the trust act and shall be liable for any misconduct or misapplication with regard to their functions as trustees or the trust properties.
- The power of the trustees shall be exercised as to ensure that the income of the trust would be exempted under section 11 of the Income Tax Act 1961 as read with sections 12.12a, and 13 or 80G other provisions of that act as amended from time to time.
- In the event of dissolution or winding up of the trust the assent of the trust remaining as on the date of such dissolution or winding up shall under no circumstance be distributed among the trustees or members of the managing committee but shall be transferred to another charitable institutions, trust, society or association whose objects are similar to those of this trust.

### DISSOLUTION OF THE TRUST :
